<u>King's Financial Bod Presentation:</u> Kendall King with King's Financial discussed bond possibilities with the board and presented various bond scenarios. No Board Action Taken.

<u>FY 2024 Budget Hearing:</u> Superintendent Gladu presented the 2023-2024 Budget. Superintendent Gladu presented the proposed revenue and expenditures. No Board Action Taken.

<u>Approval of FY 2024 Budget.</u> A motion was made by Blythe and seconded by Allen to approve the Fiscal Year 2024 Budget. Roll Call: Allen, yes; Blythe, yes; Collins, yes; Deitrich, yes; Detherage, yes; Gebhardt; yes, Walker, yes. Motion carried 7-0.

<u>Trajectory (Community Solar) Lease</u>: Kiersten Sheets with Trajectory met with the board to discuss the Community Solar Lease. The board made some changes/additions to the lease. A motion was made by Collins and seconded by Walker to approve the Trajectory Community Solar project as presented. <u>ENGIE Project & Grant Status:</u> Superintendent discussed Engie project updates Dept. of Justice Grant results for front vestibule is expected to be released the end of October. ENGIE is expected to have a design proposal for the new cafeteria/multi-purpose building at the October 2023 board meeting. No board action taken.

Old Central Office Demolition Bids: District received one bid from Alloy Group in the amount of \$85,470. The bid was for asbestos abatement only. No board action taken due to failure to meet bid requirements of abatement, demolition and removal.

<u>Concrete Bids:</u> Discussion on replacing/repairing concrete on the east side of the building. Discussion on waiting for ENGIE project updates first. No Board Action Taken.
